Mr. Wolf updated the Board on construction of the two-inch water line on Hilltop Road in conjunction with the Denton County widening work being done. The Stonebridge water line extension has been completed and is now in service. A new contractor form was reviewed and will be used for new vendors doing work for the Corporation. The sixteen-inch water line along FM407 has been experiencing a number of leaks and Staff have been exploring how these leaks could occur on a water pipe with a 100-year life. Staff will continue to explore how to determine if the entire line is deteriorating and causes. The elevated water tank at Simmons Road and FM407 is being reconditioned. Staff had asked Double Oak about continuing to have their logo on the tank, but Double Oak has declined to incur the cost of doing so. The Board requested that two large Cross Timbers WSC logos be added to the east and west sides of the elevated tank in conjunction with the recoating.

### 8. Discussion and Action on Items for the 2022 Annual Meeting

The Board reviewed the only two candidates for the two open positions and determined that no election was necessary under the Texas Water Code Section 67.055. Motion by Sherry Price and second by Larry Kaufman to approve a Resolution Declaring Unopposed Candidates of Cross Timbers Water Supply Corporation Elected. Motion approved unanimously. The Board set the Annual Meeting for April 25, 2022 to be held at the Corporation's offices at 7:30 p.m.
